Any peace officer, including any RCMP officer having jurisdiction in Yukon, who on reasonable and probable grounds believes that [first/middle/last name of person restrained] \_\_\_\_\_ is in breach of the terms of this order may immediately arrest that person and bring them before a judge of the Supreme Court promptly after the arrest, to be dealt with on an inquiry to determine whether they have committed a breach of this order.
