—	CWRR Restorative reparation process	You must attend and actively participate in a restorative reparation process as directed by your Case Manager and complete this process to the satisfaction of your Case Manager in consultation with the facilitators of the process. You must provide consent to release information to your Case Manager about your participation and completion of the restorative reparation process.
