PRACTICE DIRECTION

CRIMINAL-10 CIVIL-14 Civil Enforcement of Criminal Restitution Orders (Criminal Code, s. 741)

This Practice Direction creates a process for filing a restitution order obtained in a criminal case for enforcement as a civil judgment. It applies to restitution orders for \$25,000.01 or more, regardless of what court it was obtained in. Restitution orders of \$25,000.00 and less are enforceable through Small Claims Court. Restitution orders can be filed for enforcement if the offender has missed a payment in a payment schedule or if the amount ordered has not been paid off by the date it is due.

Where a restitution order is a "stand-alone" order and not part of a probation order or a conditional sentence order, the Plaintiff (Victim) should fill out and file a Requisition (Form A-1). A certified true copy of the original order, available through the court registry, should be attached.

Where restitution order is part of a probation or conditional sentence order, the Plaintiff (Victim) should fill out a Requisition (Form A-2), the Affidavit in Support of an Order for Restitution (Form B) and the Draft Order for Restitution (Form C).

There is no cost associated with filing any of these forms. Standard court fees apply for filing subsequent enforcement documents (e.g. writ of garnishment).
